# Making reference to EU funding



- Do not use EC, CINEA or H2020 logos!
- Use the LIFE flag + funding statement "**Co-funded by the European Union**" (translated into local languages, where appropriate)
- Please use a disclaimer whenever using the funding logo:

*Co-funded by the European Union. Views and opinions expressed are however those of the author(s) only and do not necessarily reflect those of the European Union or CINEA. Neither the European Union nor the granting authority can be held responsible for them*

# Project webpage (website)

- By default: project webpages on a partner's website
- Standalone website only in exceptional cases: to be discussed with your PA
- Should be up-to-date and attractive (target groups)
- Should not be a pure management tool for the project team
- Should not be there only to present the project and the partners
- Keep a simple structure (consider maintenance implications)
- Avoid project jargon ("deliverable", "work package" etc.)
- Upload public deliverables as soon as completed

- Collaborative activities could be considered eligible costs → liaise with your PA before!

# Main expected outputs & impacts - timeline

## Key expected outputs:

- Relaunching of the **National Qualification Platform**
- Updated **Status Quo Analysis**: skills needs and gaps in the national market (draft at M6, final at M9) → [CINEA template](#)
- Updated **National Roadmap** with action plan to 2030 (draft at M12, final by project end) → [CINEA template](#)
- Endorsement of the roadmap action plan by key **stakeholders**
- Strategy for **long-term sustainability** of the platform

## Key impacts:

- Number of **people** directly engaged through the project activities
- Number of relevant national **stakeholders** endorsing the updated Roadmap

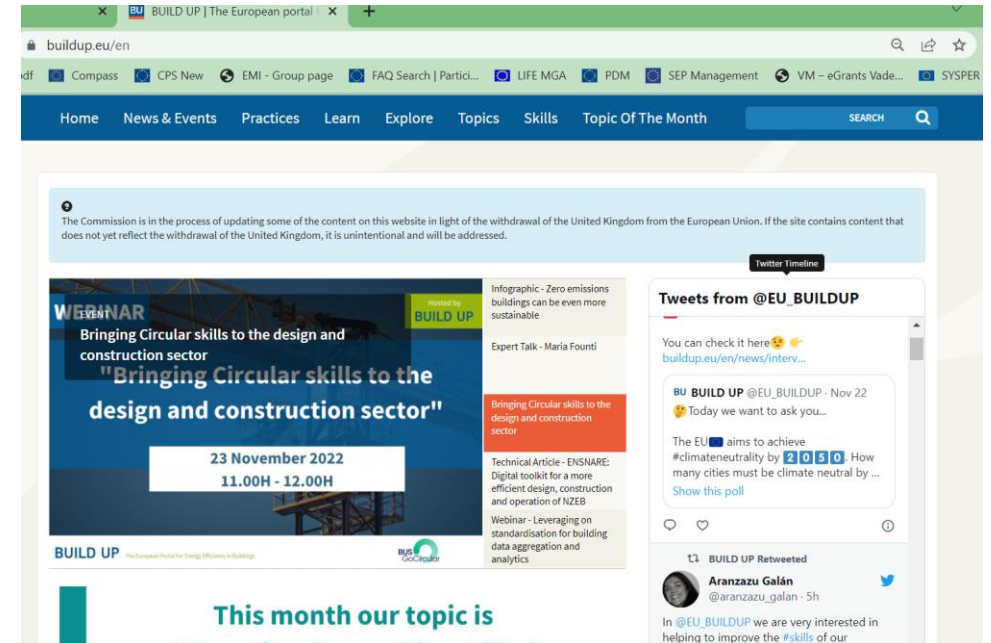
# Upcoming meetings
