Intelligent Energy Europe

 Encourages the uptake of proven intelligent energy solutions / practices

→Budget €730 million from 2007 to 2013

 \rightarrow Funding projects through annual calls for proposals

 \rightarrow Funding areas:

- Energy efficiency and rational use of energy (SAVE)
- New and renewable resources (ALTENER)
- Energy in transport (STEER)
- Integrated initiatives



BUILD UP Skills - Scope

 Multi-annual funding initiative under the IEE programme



→Focus:

- Continuing education and training (i.e. after initial education and training or after they entered working life)
- Craftsmen and other on-site construction workers and system installers
- Energy efficiency and renewable energy sources in all types of buildings



Who needs to be trained?



→**Tradesmen:** "bricklayer, carpenter, plumber, electrician, roofer, plasterer, glazier, concrete worker, steel worker, ..."

- →Supervisors, who work on site groundwork, walls, roof, windows, doors, chimneys, heating / cooling systems, air handling, lighting, other services, ...
- →Renewable energy system installers small-scale biomass boilers and stoves, solar photovoltaic and solar thermal systems, shallow geothermal systems, heat pumps
- →Specialists who select / size / check / inspect installations gas boiler, oil boiler, solid fuel burner, under-floor heating, radiators, air handling units, cooling / air conditioning plant



BUILD UP Skills - Objectives



→Initiate national discussion processes that bring together all relevant stakeholders

→Identify and quantify the need for a workforce qualified in energy efficiency and renewable energy in each Member State by 2020 (and beyond)

→Set up and agree national qualification roadmaps to achieve the sustainable energy policy objectives for 2020

→**Support concrete qualification schemes** on the basis of roadmaps to 2020 with identified needs and priorities

National qualification platforms and roadmaps (Pillar I)

- \rightarrow Launched under IEE Call for proposals 2011 and 2012
- \rightarrow Only activities on "National qualification platforms and roadmaps" eligible
- \rightarrow Application by country
- \rightarrow One proposal per country targeted
- \rightarrow Intensive promotion
- \rightarrow Maximum funding level from the EU: 90%



National qualification platforms and roadmaps (Pillar I)

Results of Call 2011

 \rightarrow High interest from the sector

- 41 proposals received from 27 countries
- 21 national projects selected
- Total EU support: EUR 7.5 million

→Duration of activities: November 2011- April 2013




National qualification platforms and roadmaps (Pillar I)

• Results of Call 2012

 \rightarrow 9 proposals received, and all were selected

 \rightarrow Total EU support: EUR 2.6 million

→Duration of activities: June 2012 – November 2013





National qualification platforms and roadmaps: engaged stakeholders



 \rightarrow All major players contribute to the national roadmap:

- relevant <u>public authorities</u>, energy and qualification agencies
- leading institutions in the continuing training system of the building sector
- accreditation and certification bodies
- installers and craftsmen associations
- <u>social partners</u> (trade unions, chambers of commerce)
- building industry and professional chambers
- energy efficient building product/equipment industry and renewable energy system <u>producers</u> and <u>installers</u>
- architects, sustainable buildings <u>experts</u>
- potential <u>financing</u> bodies.



National qualification platforms and roadmaps: what to be achieved



 \rightarrow Initiation of the **national qualification platforms** that bring together all relevant stakeholders

→Analysis of the national status quo: frame and quantify the need for qualified workers in the building sector in each Member State by 2020 (and beyond)

→Set up and endorsement of national qualification roadmaps for achievement of the 2020 energy targets as regards the continuing education and training of the workforce in the building sector

→Active participation in the EU exchange activities



Qualification and training schemes (Pillar II)

→Consortia will be invited to submit proposals for introducing new or upgrading existing large scale qualification and training schemes in EU

 \rightarrow Based on an established roadmap to 2020 with identified needs and priorities


→Support will be provided for specific activities like: development of training material, training of the trainers, coordination activities, as well as promotional and communication activities

 \rightarrow Costs related to the implementation of training courses per se will not be eligible

 \rightarrow Complemented by targeted Europe-wide support



National qualification platforms and roadmaps: what to be achieved





European exchange activities



 \rightarrow EU exchange activities for all BUILD UP Skills projects for:

- Exchange of best practice between all projects
- <u>Addressing common issues</u> in a European context (e.g. mutual recognition of qualification and training, cross-border movement of workers, etc)

→Facilitating the aggregation of results at EU level and the feed into relevant EU policy processes

 \rightarrow Building cooperation with the concerted actions

 \rightarrow Increase the visibility of the actions as joint European initiative

 \rightarrow 4 EU sessions foreseen within the time line of actions

 \rightarrow Organised by the EACI/EC
